

## 2015-16 SKI COMMITTEE MEETING

The MHSAA Ski Committee met on November 3, 2015 at the MHSAA office in East Lansing. The committee was reminded of its responsibility and the process for rule changes. The following action was taken.

#### MHSSCA PROPOSALS

# 1. Clarify/confirm the language for helmets.

Current Language is: Helmets designed and manufactured for the particular discipline of ski racing are required for all competitors and forerunners in all events and official training. Helmets must completely cover the head (no soft ears). Slalom racers must have a face guard/face mask on the helmet.

Change to: Helmets designed and manufactured for the particular discipline of ski racing are required for all competitors and forerunners in all events and official training. Helmets for Giant Slalom must completely cover the head (no soft ears). Helmets for Slalom must have an integral chin guard on the helmet. Helmets designed and manufactured for slalom with soft ears are allowed.

Refer to the rules meeting on MHSAA.com to view pictures of helmets that are legal and not legal for competition.

# 2. Change the flight for an individual skier (at the Final) if there is an odd number of individuals advancing.

The manual now reads: In the Final Meet, all individual qualifiers shall race in flights 2.5 and 4.5 with equal distribution in each flight. Flight 2.5 will have the top 50% of skiers and flight 4.5 will have the remaining skiers. In the event there are an odd number of skiers, the additional skier shall be placed in 4.5.

Change to: In the Final Meet, all individual qualifiers shall race in flights 2.5 and 4.5 with equal distribution in each flight by place out of the Regional. Flight 2.5 will have the top 50% of skiers and flight 4.5 will have the remaining skiers. In the event there are an odd number of skiers, the additional skier shall be placed in 2.5.

## 3. Approve in Concept

Allow each individual/team a maximum of 15 meets. The schedule may include school competition, CUSSA and other non-school meets. The school team schedule and racer profile must be submitted as part of the Regional Entry information. The Athletic Director must sign off on the team (and individual) schedule. Create interpretations to help clarify CUSSA and other non-school meets, as well as, the allowable non-school competition as described by limited team membership.

Recommend having the National Oceanic and Atmospheric Administration (NOAA) – As a
guideline for postponing meets- but not an absolute. The decision to postpone or cancel will be
made by hill staff, host school and the MHSAA.

- 2. Revise dates for the upcoming season
- 3. Revise: Helmet Section to read:
  - Helmets designed and manufactured for the particular discipline of ski racing are required for all competitors and forerunners in all events and official training. Helmets for Giant Slalom must completely cover the head (no soft ears). Helmets for Slalom must have an integral chin guard on the helmet. Helmets designed and manufactured for slalom with soft ears are allowed.
- 4. Revise: Running Order section to read: In the Final Meet, all individual qualifiers shall race in flights 2.5 and 4.5 with equal distribution in each flight by place out of the Regional. Flight 2.5 will have the top 50% of skiers and flight 4.5 will have the remaining skiers. In the event there are an odd number of skiers, the additional skier shall be placed in 2.5.
